



## FEDERAL BUREAU OF INVESTIGATION

Date of entry 07/28/2021

On July 27, 2021, a physical surveillance was conducted on Zebbodios Hall (Hall) at 1451 Detroit Street, Denver, Colorado. The surveillance was conducted by Federal Bureau of Investigation (FBI) Special Agents Scott Dahlstrom, Brandon Barnes, David Autrey, and FBI Task Force Officer Michael Timmerman. The following observations were made during the surveillance:

0725hrs - Surveillance initiated at the above mentioned address.

0755hrs - Hall observed exiting the back gate of the apartment complex on foot and walked north. Hall was dressed in a gray t-shirt and blue jeans. Hall was carrying a water bottle and a red sweatshirt.

0800hrs - Hall observed walking south on Clayton street and got into a gray Subaru Impreza with Colorado plates AZQY26. Hall then began driving south on Clayton street.

0820hrs - Hall arrived at 3015 South Parker Road, Suite 400, Aurora, Colorado. Surveillance was terminated at this time.

At approximately 0824hrs, SA Scott Dahlstrom, SA David Autrey, and TFO Michael Timmerman arrested Hall as he exited his vehicle and was walking towards suite 400. Hall complied with SA Dahlstrom's commands, was placed in handcuffs, searched, and placed in SA Dahlstrom's vehicle.

During the arrest, Hall asked why he was being arrested and was informed the reason for his arrest was the illegal sale of a firearm. Hall then made a spontaneous utterance of "was it Mickey?".

Hall handed over all his personal items to SA Dahlstrom and asked SA Dahlstrom to place all items in Hall's vehicle and someone would come pick up the vehicle. SA Dahlstrom placed all items in a plastic bag and put bag on the floor of the passenger side and put the keys to the car in the glove

box per Hall's request. Hall requested SA Dahlstrom contact his mother, Carol, to arrange for someone to pick up the car. SA Dahlstrom placed a call to Carol and informed her of the events and requests.

At approximately 0850hrs, Hall was transported from the arrest location to the United States Marshal's Service (USMS) by SA Dahlstrom and TFO Timmerman. The beginning mileage of the vehicle was 4,114.

At approximately 0930hrs, Hall was remanded to USMS custody. The ending mileage on the transport vehicle was 4,127.
